Format

Use 12-point type size or larger with at least ½ inch margins Please follow the outline provided Use the Summary Page as your cover page. Do not include a cover letter.

Deadline

Program Fees, October 15th Travel Fees, February 15th Camp Fees, May 15th

Application must be in by the deadlines above. If submitted past the deadline your application will not be considered. Applications can be mailed to WPSEF, PO Box 192, Winter Park, CO 80482 or drop off at the Competition Center Customer Service Desk in the Balcony House.

Funding decisions will be made within 10 days of the deadline and applicants will be informed upon committee decisions.

If you receive a grant from the foundation you will be asked to submit a brief letter outlining your accomplishments for the season and explain how the grant helped you to reach your goals.
