Please submit the application according to the directions below:

Format

Use 12-point type size or larger with at least ½ inch margins Please follow the outline provided Use the Summary Page as your cover page. Do not include a cover letter.

Deadline

Winter Programs & Travel, October 15th Summer Camp Fees, May 15th

Application must be in by the deadlines above. If submitted past the deadline your application will not be considered. Applications can be mailed to WPSEF, PO Box 192, Winter Park, CO 80482 or drop off at the Competition Center Customer Service Desk in the Balcony House.

Funding decisions will be made within 10 days of the deadline and applicants will be informed upon committee decisions. Funding will be weighted more towards need than in the past, based on your 2015 tax return and extenuating circumstances listed on the application. Estimated travel costs per program are figured into the formula.

If you receive a grant from the foundation you will be asked to submit a brief letter outlining your accomplishments for the season and explain how the grant helped you to reach your goals.

Page 3: A letter of recommendation from either a non-relative or a sports coach who is not affiliated with the Winter Park Competition Center who can discuss your commitment, potential, ability and desire to be the best.
